Department of Vedanta submitted an application for Sanskrit Yoga Study Center under the Ashtadasi project of Ministry of education in 2017. The project was implemented through erstwhile Rashtriya Sanskrit Sansthan New Delhi, which is now Central Sanskrit University, Delhi. The project was approved in 2018 wide letter file No. F. RSKS/ 36013/ Ashtadasi/ 01/2017-18 dated 3-7-2018. The project was officially started here in Govt. Sanskrit College Tripunithura on 31-07-2018. It was inaugurated by Prof. Dr. G. Gangadharan Nair the programs were sanctioned to the college. Inauguration of the programs was conducted simultaneously.

There was a good response from the part of public for the study of Yoga. Many elder people were there as learners along with the youth. The objective of the program was to impart the philosophical knowledge of Yogasastra along with the practice of Asanas. Yoga sutra along with Vyasabhashya was used for the textual study. The learners rendered the sutras and tried to understand the philosophy of Yoga through Sanskrit. There were sessions on theory as well as in practice of Asanas also. The coordinator and the co-coordinator lead the sessions. The whole text was covered during the prescribed time. There were some learners who had the practical knowledge of Asanas. They also handled the sessions in practice. Both the age groups showed greater interest in the theory classes. Many of them were having the concept that Yoga means only asanas. This concept was totally change during the theory classes.

By the end of July 2019, the sessions were concluded. The learners expressed their gratitude towards the institution for facilitating such a program. There was a fare-well meeting for the learners on 31st of August 2019.
